1.0 CALL TO ORDER 7:07 pm

- 1.1 Treaty Land Acknowledgement
 - 1.1.1 The Ponoka Jubilee Library Board acknowledges that we are located on Treaty 6 territory, and respects the histories, languages, and cultures of First Nations, Metis, Inuit, and all First Peoples of Canada, whose presence continues to enrich our vibrant community.

2.0 FINANCE

- 2.1 Financial Report for April 2023
 - 2.1.1 Donations down slightly due to fewer participants at trivia night.
 - 2.1.2 Grant of \$10 000.00 received from the PLSB (Public Library Services Branch). Will be used for operating the lending library, resume printing and 3 sessions will be available to the public in September, October and November of 2023. Focusing on resume building, interviewing for employment and job skills.
 - 2.1.3 A donation of \$850.00 from the Schmidt family is expected in the next while.
 - 2.1.4 Overall budget to date is on target.

3.0 LIBRARIAN'S REPORT

3.1 Statistics

- 3.1.1 Library usage is down slightly possibly due to the nice weather and the long weekend.
- 3.1.2 Circulation is up and all other statistics are level.

3.2 Collections

- 3.2.1 The nostalgia collection that was created in April is seeing some movement. Feedback has been positive.
- 3.2.2 The seed library is operational. There have been many community donations and borrowers. The seed library will run until mid to late May or early June depending on when the seed collection is depleted.
- 3.2.3 The Junior Fiction and Young Adult Collections are in the early stages of being organized according to genre. This approach aims to enhance user experience by making it easier for patrons to locate books and resources and can allow for faster and more efficient retrieval of items.

3.3 Operations

- 3.3.1 Funding through Canada Summer jobs has been confirmed. This allows for two summer student positions.
- 3.3.2 The library manager will reach out to Young Canada Works for a progress update on whether funding is secured.
- 3.3.3 If the library is not successful in getting the Young Summer Works grant the library manager will reach out to Canada Summer Jobs for 100% funding rather than 75%.
- 3.3.4 The library manager and PJLB HR committee are working through the book Crucial Conversations. To date it has been a very useful process and a positive experience.

3.4 Programming Report

- 3.4.1 Seniors' tea continues to be a very popular program and is well attended. This program will run throughout the summer.
- 3.4.2 Family movie nights are typically not well attended so discussions will be had about their viability.

3.5 Outreach Report

3.5.1 Outreach programs have been steady. Some visits were missed do to staff or patron illness.

4.0 Reports

- 4.1 Town of Ponoka Report
 - 4.1.1 Library board has been invited to a luncheon and rodeo on June 30. A big thank you for the invitation.
 - 4.1.2 Town council will potentially meet with the library board chair to get introduced. Cal will confirm the date with Alison.
 - **4.1.3** Andrew Jones is working on the new lease. Nothing has been presented to the town at this time.
