**2.1** Financial Report: Ben presented the financial report. He noted that the donations that were approved in response to his requests will be reflected in next month's report.



### 3. ITEMS FOR DISCUSSION

**3.1** Provincial mandates, facility rentals and fundraisers: Current Covid-19 mandates deem libraries to be essential services but also prohibit any indoor adult programming. In light of this, Ben spoke to Municipal Affairs and PSLB to find out if there is any way to proceed with the annual Gaming Extravaganza fundraiser in three weeks. He was informed that libraries are still allowed to rent space to other groups provided they follow Alberta Health rules. The Friends of the Rocky Public Library Society is an enthusiastic fundraising group who would be happy to host this event. If they opt into the restriction exemption program that requires proof of vaccination then the event can proceed, including food service. The board supports this initiative.
